Shipping and delivery expenses

By rule products are dispatched within 72 hours from the order of the products that are available or within seven days for a product that is not currently available (depending on the availability). All the expenses for the delivery will be written clearly on your order and will not include insurance (unless you desire this). You will be informed by e-mail for possible delays in your order and will have the possibility of partial delivery if this is possible.

Please ensure that you write the correct delivery postal address on your order, since we will not be held responsible for packages that are lost because they were sent to wrong or incomplete addresses without the mistake being ours.

Product returns, Exchanges & money refunds

Returns policy

Our aim is to guaranty your complete satisfaction. If, for any reason, you do not remain satisfied with your order, you can exercise your right to return the products that you have purchased within seven (7) days from their date of receipt.



All the delivery expenses of the returns, with the exception of returns due to damaged products and/or products that were sent by mistake, burden you. Exis by Ntovellou e-shop will cover the dispatch costs for damaged products and products that were sent by mistake. In this case resort all the products will be sent using only the transportation company used by our company.

Terms and Conditions of Returns

In order to accept that you have correctly exercised your right to return a product you will have to fully comply with the following requirements:

- 1. To inform an authorised employee of Exis by Ntovellou e-shop and to have their positive answer of acceptance of the return.
- 2. The products should not be used, worn, washed, changed or have been damaged and the packaging together with all the labels of the designer are to be found affixed to the product. All the products that are sold by Exis by Ntovellou e-shop are accompanied by packaging. We remind you not to try the products that you buy, since we do not accept returns of products that are not in the same condition that they were delivered. For hygiene reasons, many of our products are in no case returnable. For more information on this, please contact our company.
- 3. The products must be returned complete and unused, in their original packaging. If the returned boxes of products have been damaged, your return may not be accepted.
- 4. The products must be returned to Exis by Ntovellou e-shop within seven days (7) from the day that you received them from Exis by Ntovellou e-shop.

Products that are returned after this allowed time of seven (7) days from the date of delivery of the order will be accepted only at the discretion of Exis by Ntovellou e-shop and reimbursed only with credit for future purchase of another product.

5. If you return more than one type of product from the same order, you will have to send it once: Exis by Ntovellou e-shop does not accept multiple returns of the same order, with the products being sent at different times.

If you fulfill all the above requirements, Exis by Ntovellou e-shop will refund the total amount of value of the purchased products that you have returned, except for the expenses of the initial dispatch (exempt is the case for Faulty Goods) that will have to be deducted to cover the cost of the initial dispatch.



In case that the returned products are not accepted, you will be informed of this by Exis by Ntovellou e-shop. In this case, you can choose to have the products delivered from Exis by Ntovellou e-shop at your expense. If you refuse the above delivery, Exis by Ntovellou e-shop retains the right to keep the products and the amount that was deposited to buy the products.

Faulty Products

All the complaints are dealt with in good will. The products are characterized as faulty if during their delivery they are subject to damage or if they present a manufacturing defect within one month of their purchase. Please keep in mind that the products that suffer damage due to use or wear and tear are not considered being faulty. All the products that show obvious manufacturing defects will be replaced or reimbursed immediately. As such, we retain the right, in case of doubtful complaints, to return the product to the manufacturer for inspection, in order to investigate if the complaint is real. We will keep the customer informed of the progress of his complaint. The procedure may take up to 30 days.

If you wish to exchange a faulty product, please bear in mind that we can replace it only with the same product of the same size, depending on availability of products.

Money refund

As soon as Exis by Ntovellou e-shop receives the products and checks that they fulfill all the requirements for return, you will receive an e-mail to inform you that the product has been accepted.

The value of the product will be credited to the credit card of the initial purchaser or to the account of Exis by Ntovellou e-shop deducting the delivery expenses (with the exception of faulty products or the products that were sent by mistake) that are kept to cover the cost of the delivery.

Irrespective of the method of payment that will be used (Debit or Credit Card, Money Order etc), the money refund process begins 30 days after Exis by Ntovellou e-shop informs you of acceptance of your decision to exercise your right to return the product that you purchased and after Exis by Ntovellou e-shop checks that the return was done in accordance with the above requirements.



The time interval for return of the amount that was deposited to purchase the products that were returned depends on the method of payment that you used:

1. Credit or Debit Card

The time for money refund depends on the policy of the company that issued your card.

2. Money Order – Bank transfer

The amount that you paid for the products that you returned will be refunded to your bank account which will be requested from you. The time that is required for the refund of money depends on the information that you gave when ordering. Usually the money is refunded within one month. Please bear in mind that it is necessary to have a bank account to receive the money refund for orders that were paid by Money Order. If your order was sent to a destination inside the EU, all the taxes that are in effect for the sale will be refunded. For destinations outside the EU, the customs charge and taxes for the sale are not refundable from Exis by Ntovellou e-shop. Try to communicate directly with the customs services of your area and once you forward them the refund receipt logically they will return the taxes.

Orders

All the orders must be accepted by us and are subject to availability. Exis by Ntovellou e-shop offers for sale products that are available for dispatch from our distribution centre.

If you have given your electronic address to be informed of the arrival of particular products that are presented on our webpage, we will try to inform you by e-mail within 48 hours of the product becoming available on the webpage. Bear in mind that sometimes some products that have especially large demand will have been sold within this interval.

The prices shown on the webpage are in EURO and include VAT.

All the prices and the offers continue to be valid as is noted from time to time. The charge of a product will be done in the Euro price shown on the webpage at the moment of acceptance of the order. The final price for customers abroad is calculated according to the exchange rate that is valid on the day that the company that issued the invoice processes the transaction.



Acknowledgment and acceptance of your order

If you have given your electronic address, we will inform you as soon as possible by e-mail to confirm that we have received your order and we will inform you again by e-mail or telephone to confirm that we accept your order. This e-mail does not mean that your order has been accepted. Your order will not be accepted if we detect substantial mistakes in the prices that are written on our website. If you have not given us your electronic address, the confirmation page of the order at the end of the order procedure on the website will be the confirmation that we have received your order. There will not be any communication until you receive from us confirmation that your order has been accepted and then we will proceed with the debit of your credit or debit card after we first check the data of your credit or debit card. If there are changes in the data that you have given us, you must inform us as soon as possible. At the point where we send you the products the sale agreement will be compiled by us on which we inform you that your order has been accepted via e-mail or verbally by telephone. In case that we proceed to debit your card and discover substantial mistakes in the order, we maintain the right to a money refund to your card and to cancel the order.

We reserve the right to not accept your order, for example if we do not manage to obtain payment authorisation, when there are limits to the transportation of a particular type, when the product that you have ordered is not available or does not satisfy the quality control standards and is recalled, or if you do not fulfil the suitability criteria that are mentioned above.

Additionally, at any point in time, we may refuse to process a transaction for any reason or refuse to serve a person, at our discretion.

We are not responsible towards you or towards any third parties if we recall any product from our webpage, irrespective of if the particular product has sales or not, if we delete, correct or change the material or the content of the webpage, or if we refuse to process a transaction or cancel or postpone a transaction after its processing has already begun.

Payment

The payments can be made with debit cards Visa, Visa Electron, MasterCard, American Express and by Bank transfer. The payment will be charged and will be taken from your account as soon as Exis by Ntovellou e-shop receives your order. You will confirm that the credit/ debit card that you use is yours. All the holders of credit/ debit cards are subject to validity checks and authorisations from the organisation that issued the card.



If the organisation that issued the card refuses to give Exis by Ntovellou e-shop authorisation for the payment, we will not be considered responsible for possible delays or non delivery.

We make every possible effort to make our webpage as safe as possible. All the transactions via credit cards on this website are processed by the ALPHA BANK using their payment technology, a safe payment web gate that encrypts the data of your card to a safe environment on the central computer.

Additionally, we make every possible effort, to the degree that we are able, to maintain the data of your order and payment as confidential, but provided there is no negligence on our part we are not responsible for possible loss, to your detriment, if any third party gains non-authorised access to the data that you give us when you enter our webpage or complete orders from it.
